## TOWN OF SANDY CREEK WATER ADVISORY COMMITTEE MEETING MINUTES

**Date:** July 31, 2017

The meeting was called to order at 6:07 PM by Chairman Norma Newman with the Pledge of Allegiance.

A motion was made by Cindy Love, and seconded by Wayne Miller, to approve the June 26<sup>th</sup> minutes, all in favor.

Bonnie Reid inquired about funding for the water project. Norma Newman explained that we have sent in our application for funding. Mike Kastler explained that our application was lacking a few items beyond our control. We are still waiting on approval from the Comptroller's office.

Mike Jennings asked when, in a perfect world, the new water district would be starting. Mike Kastler explained that we will not know our results of the funding until September or October at the earliest. If the application is not approved then we would need to resubmit our application in May or June of next year. The Town Board recently voted to form the District.

Mike Jennings also expressed his approval of the new automatic water salesman at 99 Weaver Road. He said it is cheaper than paying to have his water delivered to his well.

Wayne Miller requested that we add information about the automatic water salesman to the website.

Mike Kastler gave an update. The water salesman is being used daily. Hydrants in both water districts have been mowed and exercised. Quite a few people have had their well water tested. Several have been positive for Coliform and/or E. Coli. There was a great turnout for the meeting at the Sportsman's Club regarding flooding information. FEMA will be meeting with Town Supervisor Nancy Ridgeway on Tuesday to discuss their results.

Chairman Norma Newman informed everyone about an email Tammy Miller received from a homeowner regarding the contaminated wells from the flooding.

Chairman Newman asked the committee if they had any questions or concerns about the Map Plan and Report. Wayne Miller had the same question as last month regarding page 7. Mike Kastler explained the wording to Mr. Miller. Further clarification from Barton & Loguidice may be needed.

The most recent Barton & Loguidice water update was also discussed.

Chairman Newman let the committee know that there are a couple EDUs that she needs to research and discuss at the next meeting.
