No decision was made at the last Town Board meeting regarding the EDU assignment of campers. Wayne Miller informed the committee that he never received a list of properties with campers. Miss. Washburn explained that no such list exists. Mr. Miller will need to ask the Assessor for a list of all properties in each water district and then check each individual property to see if there are any campers present. Mrs. Newman believes that there are not many properties with campers. Mr. Miller believes that this issue is not a water issue but a code enforcement issue. A lengthy discussion regarding the camper EDU issue followed.

At the last committee meeting the committee recommended that the EDU for Colonial Court Campground remain the same. A vote was not taken at the last Town Board meeting as there was no change.
