# **CALL TO ORDER:**

Supervisor Nancy Ridgeway called the meeting to order at 6:00 pm with the Pledge of Allegiance. There are currently two vacancies on the Water Advisory Committee and the alternate position is also vacant.

# **PUBLIC COMMENT:**

Sami Maalouf of Waful Shores stated that there are five homes in his neighborhood that want public water. Kathy & Jack McGarghan of Co Rt 15 expressed their desire for public water. Frank Dixon of Sand Road would also like public water.

Water Superintendent Michael Kastler explained how water districts are formed and answered questions about the process. A lengthy discussion followed.

The latest draft of the local law establishing rules for operation of the water system was reviewed and some changes were discussed. The areas of concern will be discussed with Attorney Nelson and the appropriate changes made to the draft.

A letter was received from Colonial Court Campground asking for a review of their EDU assessment. Water Clerk Brittany Washburn provided the committee and Town Board with a comparison of all of the parks and restaurants in the water districts. This data was discussed for possible updating.

The EDU assessment on the Surprise property was discussed. Mrs. Surprise wants the EDU lowered for the property as it only contains a shed. It is believed that the shed is used as a cottage and a curb stop was requested there. No adjustment was recommended at this time. The water clerk was asked to send a letter explaining the decision.

Some EDU adjustments were recommended to the Town Board by the Water Advisory Committee. Water Superintendent Mike Kastler stated that any change to the Wallis properties should be placed on hold until the maps are checked. Mr. Wallis requested two curb stops on Carr Drive.
