WATER ADVISORY COMMITTEE MEETING MINUTES**

Date: November 28, 2016

Place: Sandy Creek Town Hall

Water Advisory Committee Members Present: Norma Newman, Wayne Miller, Cindy Love, Cheryl Yerdon, Roy Narish and Pat McDougal.

The meeting was called to order at 6:01 PM by Chairman Norma Newman with the Pledge of Allegiance.

Approval of the October 24, 2016 Minutes. On motion by Cindy Love and seconded by Wayne Miller, all in favor.

Public Comment: Marcy Newman from United States Department of Agriculture, Rural Development was present. Marcy explained that USDA- RD has 42 different programs that they offer through their office. There is a program directed towards home repairs. This program may be an option for those that are on a fixed or low income to help connect to the water system. Dustin Clark and George Kalkowsky from Barton and Loguidice were also present. Mr. Clark explained what has been going on with Proposed Water District #3 up to this point. A discussion was held about segments of roads and the responses regarding water interest.

Frank Dixon of Sand Road expressed his interest in water at his property. Mr. Dixon hauls water to his property frequently.

A lengthy discussion was held about water costs.

Mike Kline of Wilder Drive has talked with his neighbors and compiled a list of Yes/No's regarding interest in water to their properties.

Michael Kastler, Highway & Water Superintendent, said the paving at the metering station and water tower have been completed. Fencing will be completed soon, and then Water District #1 should be complete.

Old Business: Norma Newman spoke with the Water Advisory Committee about polling Hadley Road, Co Rt 62, Sawmill Road, and Hilton Road. These roads will need to be polled by the January 30th meeting.

New Business: There are two property owners that have split their parcels. On motion by Pat McDougal and seconded by Cindy Love, all in favor. The Water Advisory Committee recommends the following EDU changes for the 2017 Tax Roll.
