

**TOWN OF SANDY CREEK  
WATER ADVISORY COMMITTEE MEETING MINUTES**

**Date:** November 30, 2015

**Place:** Sandy Creek Town Hall

**WAC Members Present:** Jim Forsythe, Roy Narish, Wayne Miller, and Norma Newman.

**Others Present:** Mike Kastler, Nancy Ridgeway, John Wood, Jr., and Brittany Washburn.

The meeting was called to order at 6:02pm by Norma Newman, with the pledge of allegiance.

**Approval of Minutes:**

On motion by Wayne Miller, seconded by Roy Narish, the meeting minutes for July 27, 2015 and October 26, 2015 were approved. All in favor.

**Public Time:**

Mike Kastler gave an update on all water districts:

**WD#1** – We are done with additional work that needed to be completed. We have applied to have paving done by the metering station on Rainbow Shores Road, and on Weaver Road to the Water Tower. There are two hydrants that need to be relocated and two services to be added to the district.

**WD#2** – There are two services left to be completed on Carr Drive by Wednesday. All restoration work is completed. There are two directional drills left. There will be a walk though on Thursday 12/02/2015. There is a notice from the Village of Sandy Creek; they will be charging an extra \$0.20 cents per 1,000 gallons. The charge from the Village is now at \$6.09 per 1,000 gallons of water. This brings the total charge to the water users in WD#2 to \$6.50 per 1,000 gallons, or \$130 every 6 months.

**WD#3** – We are still working on getting more responses from homeowners in what could be district 3.

**Resolved** that the Town Board of the Town of Sandy Creek approves the addition of 0.25 Edu's for each camper actively used on a residential parcel currently receiving an EDU charge. Added rooms, roofs, or decks are indicative of use on the parcel, although not required for the additional unit charge.
