WATER ADVISORY COMMITTEE MEETING MINUTES**

The meeting was called to order at 6:03 pm by Norma Newman with the Pledge of Allegiance.

Chairman Norma Newman introduced Engineer Anthony Young P.E. from Barton & Loguidice to the committee. The meeting was then turned over to Mr. Young. Mr. Young handed out the most recent B&L Water Update to those that needed it. (*The water updates are available on our website on the water department tab*) A pre-construction meeting was held on Friday, July 24th with representatives from the Town of Sandy Creek, Town of Richland, Oswego County Health Department, Barton and Loguidice, and W.D. Malone Trucking and Excavating. We plan to start construction by mid-August. There will be several crews working on this project over the next two years.

Chairman Newman is concerned about the number of outstanding easements still needed for the project.

With no other questions for Engineer Anthony Young, he left the meeting at 6:26 PM.

Wayne Miller would like to “breathe fresh air” back into the past discussion on EDU assignments for campers. The Town Board had tabled their discussion on EDU assignments last year. The committee would like to know if the Town Board has made a decision to change the wording on the EDU assignment for campers.

The owners of Colonial Court Campground submitted a letter requesting a review of the current EDU assessment. A lengthy discussion followed.

A motion was made by Pat McDougal and seconded by Cindy Love, to recommend that the Town Board keep the rate as is for Colonial Court Campground.
