**RESOLUTION 44-15  
WITHDRAWING FUNDS FROM THE HIGHWAY EQUIPMENT RESERVE  
FUND**

**WHEREAS**, the Town of Sandy Creek owns and maintains a tractor and mowers which are in need of replacement; and

**WHEREAS**, the Town of Sandy Creek Highway Superintendent, Michael Kastler, has obtained a quote for a 2015 New Holland TS6110 tractor, a 835TL Loader, a 2015 Diamond 16’3 pt. Hitch Boom Mower, 42” Flail Cutter Head with Brush Knives, Electric over Hydraulic Non-proportional Joystick Controls and a 2015 Diamond 90” Rear Offset Flail Cutter for a purchase price of \$95,403; and

**WHEREAS**, the Town Board of the Town of Sandy Creek maintains a Highway Equipment Reserve Fund Account pursuant to General Municipal Law for the purpose of acquiring, repairing and maintaining Town highway equipment; and

**WHEREAS**, the Town of Sandy Creek’s tractor and mowers are in need of replacement and the Town Board wishes to expend monies from such reserve account to acquire a 2015 New Holland TS6110 tractor, a 835TL Loader, a 2015 Diamond 16’3 pt. Hitch Boom Mower, 42” Flail Cutter Head with Brush Knives, Electric over Hydraulic Non-proportional Joystick Controls and a 2015 Diamond 90” Rear Offset Flail Cutter for a purchase price of \$95,403;

**NOW ON MOTION** made by John W. Wood, Jr. and seconded by Nancy Ridgeway, **BE IT RESOLVED** as follows:

1. That the Town Board of the Town of Sandy Creek does hereby authorize a sum not to exceed \$95,403 to be appropriated from the Highway Equipment Reserve Fund towards the purchase of a 2015 New Holland TS6110 tractor and a 835TL Loader, a 2015 Diamond 16’3 pt. Hitch Boom Mower, 42” Flail Cutter Head with Brush Knives, Electric over Hydraulic Non-proportional Joystick Controls and a 2015 Diamond 90” Rear Offset Flail Cutter.

This Resolution shall be subject to a permissive referendum as permitted by law.
